



WHRC WORKS TO SLOW TROPICAL DEFORESTATION, THEREBY HELPING DEVELOPING COUNTRIES TO MEET THEIR COMMITMENTS UNDER THE PARIS CLIMATE AGREEMENT TO REDUCE GREENHOUSE GAS EMISSIONS. REFORESTATION REMOVES CO2 FROM THE ATMOSPHERE AND ACTS TO REVERSE CLIMATE CHANGE. WE WORK WITH GOVERNMENTS AND NGOS TO IDENTIFY AND IMPLEMENT OPPORTUNITIES FOR REFORESTATION. ALSO, WHRC USES SATELLITE AND OTHER DATA TO MEASURE CHANGES IN FOREST CARBON STORAGE. THIS CONTRIBUTES TO MEASUREMENT AND REPORTING OF NATIONAL GREENHOUSE GAS EMISSIONS UNDER THE PARIS CLIMATE AGREEMENT.

4b (Code:) (Expenses \$ 803,150. including grants of \$ 227,958.) (Revenue \$) WATER - ANALYSIS OF STREAM AND RIVER WATER IS A POWERFUL TOOL FOR UNDERSTANDING CHANGES TAKING PLACE ON LAND. IN THE ARCTIC, FOR EXAMPLE, WHRC SCIENTISTS ANALYZE THE CARBON DISSOLVED IN RIVER WATER TO DETERMINE THAWING OF PERMAFROST DUE TO CLIMATE CHANGE. ALSO, DEFORESTATION RESULTS IN CHANGES TO CLIMATE AND WATER BALANCE AT SMALL AND LARGE SCALES. THIS CAN REDUCE PRECIPITATION ENOUGH TO THREATEN THE VIABILITY OF AGRICULTURE. WHRC SCIENTISTS LEAD FIELDWORK AND MODELING PROJECTS TO BETTER UNDERSTAND THE CONSEQUENCES OF THESE CHANGES AND TO LINK TO POSSIBLE MITIGATION STRATEGIES, POLICIES, AND SOLUTIONS.

(Revenue \$) SOILS - THAWING OF FROZEN SOIL (PERMAFROST) IN THE ARCTIC RELEASES GREENHOUSE GASES TO THE ATMOSPHERE AND IS A POTENTIALLY MAJOR AND UNCONTROLLABLE CONTRIBUTOR TO CLIMATE CHANGE. WHRC IS A LEADER IN CONDUCTING RESEARCH TO UNDERSTAND HOW MUCH AND HOW QUICKLY PERMAFROST THAW WILL ADD TO CLIMATE CHANGE. WE ALSO WORK WITH NATIONAL AND INTERNATIONAL POLICYMAKERS TO IDENTIFY POLICY MEASURES TO HELP CONTROL THE PROBLEM. OUTSIDE OF THE ARCTIC, INCREASING SOIL CARBON STORAGE IS A POTENTIALLY POWERFUL WAY TO REMOVE CO2 FROM THE ATMOSPHERE AND ACT TO REVERSE CLIMATE CHANGE. WE WORK WITH NGOS AND GOVERNMENTS TO IDENTIFY AND IMPLEMENT OPPORTUNITIES TO DO THIS. IN ADDITION, WE WORK TO IMPROVE MEASUREMENTS OF SOIL CARBON STORAGE, WHICH ARE NEEDED TO ACCURATELY TRACK PROGRESS.
